We will have an ethics CLE on January 25, 2024. That said, please be sure to check your emails and our website, which is often updated with additional information.



#### In Memoriam Julius S. Boccia

Julius S. Boccia, a native of Beacon and a member of the Dutchess County Bar Association for close to 60 years, passed away after a short illness on February 2, 2023. He joyfully served the legal profession in a variety of roles during his career.

He graduated from St. John's Law School in 1954, passed the bar exam, was admitted to the Bar and immediately began military service in the U.S. Army during the Korean War. He was stationed in Germany with the 2nd Armored Infantry Division (Hell on Wheels) from 1954-55. Upon returning to civilian life, Julius practiced law with Canio Salese and others until obtaining an appointment as an Assistant District Attorney by District Attorney Raymond Baratta, where he served from 1959-63. He always recalled his days as an ADA with much pleasure, saying it was the best job he ever had, and remained life-long friends with Judge Baratta.

Upon leaving the DA's office, Julius entered private practice in the Beacon law office, Phillips, Heaney and Schofield in 1963, where he remained until his retirement. In that capacity, he enjoyed the general practice of law, specializing in real estate, estate practice and the representation of lending institutions. All attorneys who had the good fortune of dealing with Julius came away with the appreciation of dealing with a true gentleman whose word was his bond. He had a smile on his face at all times, never taking life too seriously. Julius was a mainstay at Dutchess County Bar Association meetings, even in his retirement!

A life-long registered Republican, Julius ran for elective office once, in 1967. He lost a race for a seat in the Dutchess County Legislature by 2 votes! In 1992, the Beacon City Council appointed Julius as Asst. City Court Judge and he ascended to City Court Judge when City Judge Anthony Pagones retired. He served in that position until 2000.

Julius served the Beacon and Southern Dutchess County community in a variety of charitable organizations over the years: the Knights of Columbus, St. Rocco's Society, Elks Club and the Southern Dutchess Exchange Club. He is survived by his wife, Marian, two step-children, as well as a brother and a sister.

As a personal note, Julius was my father, Tom Forman's best friend. They were business partners in Sylvan Lake Beach Park and 33 Henry Street business offices for close to 30 years. Growing up, Uncle Julie was truly part of our family. Until his marriage, he ate breakfast with us every Christmas morning. He was the reason I became a lawyer (although both he and Canio Salese tried to talk me out of it). I always felt he was the ultimate role model of how to conduct oneself both personally and professionally. He will be missed by all of us who knew and loved him.


